PCM brings together individuals and organizations that share a common interest in mediation as a method of dispute resolution. Our annual conference provides an opportunity for mediators to network with other mediators, learn new skills and enhance their mediation practice. Our audience is a mixture of attorney-mediators, practitioners with training in social work and the behavioral sciences, volunteer community mediators, and others interested in dispute resolution.

Previous attendees have requested such workshop topics as mediator ethics, working with interpreters, conflict coaching, uncovering bias, family conflict (beyond divorce/custody), court-mandated mediation and mediation confidentiality.
